RESOLUTION NO. 14-10

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF AMITY, BERKS COUNTY, PENNSYLVANIA ESTABLISHING A LIST OF RECYCLABLES THAT ARE TO BE SEPARATED AND SEGREGATED BY THE GENERATOR FROM THE MUNICIPAL WASTE STREAM BY ANY SINGLE FAMILY OR MULTI-FAMILY DWELLING (CONTAINING FIVE (5) OR LESS RESIDENTIAL UNITS) FOR CURBSIDE DELIVERY TO THE AMITY TOWNSHIP RECYCLABLE COLLECTOR AND ESTABLISHING DATES FOR SUBMISSION OF A PROGRAM FOR SOURCE SEPARATION, SEGREGATION AND DISPOSITION OF RECYCLABLE MATERIALS AS IDENTIFIED IN A LIST OF SUCH MATERIALS FOR COMMERCIAL OR INSTITUTIONAL ESTABLISHMENTS.

WHEREAS, the Board of Supervisors of the Township of Amity adopted Ordinance 91-127 on August 19, 1991 establishing certain regulations for municipal waste and recyclable collectors in accordance with the Act of July 28, 1988, No. 101 known as the "Municipal Waste Planning, Recycling and Waste Reduction Act"; and

WHEREAS, said Ordinance adopts and proposes implementation of a plan of recycling for single family and multi-family dwellings with separate provisions for preparation and implementation of a plan for source site recycling separation and segregation for commercial and institutional establishments, which will effect the conservation and natural resources, the protection of the right of the people to clean air, pure water, and the preservation of the environment; and

WHEREAS, said Ordinance authorizes the Board of Supervisors of Amity Township to establish a list of recyclable materials to be subject to separation and segregation by single family and multi-family structures (containing five (5) or less residential units) and authorizing the Board of Supervisors to require the preparation and implementation of a program for source site recyclable separation and segregation by commercial and institutional uses or multi-family uses consisting of six (6) or more residential units for an identified list of recyclable materials subject and pursuant to the terms of the aforesaid Ordinance.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Amity, Berks County, Pennsylvania, that:

1. All single family residential uses and multi-family dwellings without regard to the number of residential units they contain shall segregate and separate from the municipal waste stream and deliver to the curbside for collection by the authorized

Amity Township recyclable collector, or such collector as may be provided by the owner or any multi-family dwelling containing six (6) or more residential units, the following items:

- a. Curbside Pick Up
  - (1) Glass (clear and all colors)
  - (2) Aluminum and tin cans
  - (3) Plastic #1 through #7 bottles and containers only
  - (4) Mixed paper (newsprint, cardboard, corrugated boxes, magazines, office paper, junk mail, paperback books, phone books, gift wrapping, boxes, paper and catalogues)
  
- b. Semi-Annual Curbside Pick Up/Drop Off Container
  - (1) Yard Waste - Clean yard waste, brush, tree trimmings, leaves, land clearing, stumps, fallen trees

2. The owners and occupants of all commercial establishments, institutional establishments, and multi-family residential dwellings consisting of six (6) or more residential units, shall prepare a program for the separation, segregation and disposition of recyclable materials, as hereinafter identified, in compliance with the Pennsylvania Solid Waste Act, Act 101, for submission to the Township on or before October 31, 1991, or within ten (10) days of the initiation or occupancy of such use should the same occur following the effective date of this Resolution and propose the implementation of such plan on or before November 30, 1991, or within ten (10) days following the initiation and occupancy of such use should the same occur following the effective date of this Resolution, subject to inspection, confirmation and enforcement by such agents, servants, or employees of the Township as may be designated by the Board of Supervisors from time to time.

3. That all owners and occupants of commercial establishments and institutional establishments shall provide for the separation and segregation of recyclable materials consisting of:

- a. Glass (clear and all colors)
- b. Aluminum and tin cans
- c. Plastic #1 through #7 bottles and containers only
- d. Mixed paper (newsprint, cardboard, corrugated boxes, magazines, office paper, junk mail, paperback books, phone books, gift wrapping, boxes, paper and catalogues)

4. The inspection, confirmation of implementation, and enforcement of this Resolution and the Ordinance establishing a collection program for recyclable materials

for Amity Township shall be undertaken by such employee, servant, agent or independent subcontractor as may be determined necessary and appropriate by designation of the Board of Supervisors of Amity Township in accordance with Ordinance No. 91-127, hereinbefore enacted and ordained by the Board of Supervisors of Amity Township August 19, 1991.
