# Amity Township Board of Supervisors Reorganization Meeting Agenda January 2, 2007

Motion by Mrs. McGrath, seconded by Mr. Weller, to open the floor for nominations for Temporary Chairperson. Motion passed unanimously.

Mr. Yanos moved, seconded by Mr. Weller, to nominate Mr. Gokey as temporary Chairperson. Motion passed unanimously.

Motion by Mrs. McGrath, seconded by Mr. Weller, to close the floor for nominations for Temporary Chairperson. Motion passed unanimously. Mr. Gokey was unanimously elected Temporary Chairperson.

**<u>FIRE COMPANY REPORT</u>** Chief Richter presented his yearly report and officers for 2008.

**EDAC** Bob Elsas reported that the EDAC will discuss the 422 interchange at their next meeting. He stated that the Township needs to make it more accessible and more effective.

**EAC** Jennifer Huha reported that the EAC was working with the County to provide radon pamphlets to all residents in the Township. Mr. Gokey asked if there was grant money available to supply the residents with radon kits. She stated they are also working on an environmental resource inventory. Mr. Yanos moved, seconded by Mrs. McGrath to appoint Scott Stepp as liaison to the EAC for 2008. Motion passed 5-0.

**RECREATION BOARD** Risa Marmontello reported that the Rec Board had designated the fees from the I & G development to Amity Community Park. She stated that the Rec Board would like to pursue reevaluating the rec fees collected from developers. Mr. Boland stated that he should have the report from Doug Haring shortly. Ms. Marmontello reported that the Forest Stewardship Committee had compiled the results from the survey

and comments from people that had attended the meetings. She stated that January 17 was the presentation of the information and last chance for input from the public.

#### **UNFINISHED BUSINESS**

*EDU Policy Discussion* Mr. Yanos moved to table. Motion passed unanimously. *Weavertown Traffic Study* Mr. Yanos moved to table. Motion passed unanimously. The Board preferred to wait until the engineer was present to discuss.

**Resolution 08-02 Fee Schedule** Mr. Stepp moved, seconded by Mr. Gokey to approve Resolution 08-02. Motion passed 5-0.

**2008 Meeting Dates** Mr. Yanos stated it was important to have the same attorney at the Supervisor's meetings. After discussion it was decided that the meeting dates would be changed to the 1<sup>st</sup> and 3<sup>rd</sup> Wednesdays. The Zoning Hearing Board would discuss alternate dates for their meeting. Mr. Yanos moved, seconded by Mr. Stepp to authorize the advertising of the new meeting dates. Motion passed 5-0.

**Pulte Homes EDU Refund Request** Mr. Boland stated that he would notify Greystone Capital Partners of Pulte's request and give them an opportunity to make arrangements with Pulte regarding their refund. Greystone would then report the results to the Township.

#### **SOLICITOR'S REPORT**

Mr. Boland presented Resolution 08-01 (appointing Long & Barrell as auditors) to the Board for signatures. Mr. Boland stated that he could make available an afternoon for the new Supervisors to discuss ongoing issues. Mr. Gokey stated it might be a good idea to have the engineers available as well.

#### **NEW BUSINESS**

*Ralph Hartzell Vacation Rollover Request*. Mr. Yanos moved, seconded by Mrs. McGrath to approve 3 day vacation rollover for Ralph Hartzell without setting precedence. Motion passed 5-0.

**SMO Report and Request for Direction** Steve Loomis had set forth a procedure for those residents that had not complied with the SMO ordinance. Mr. Gokey moved, seconded by Mr. Yanos to follow the procedure, provided that the letters are sent certified mail and that it is specified that this ordinance is mandated by the State. Motion passed 5-0.

#### **EMPLOYEE/OFFICIAL REPORTS**

*Manager.* The manager reported that there had been a sewer break along 422 over the Christmas holiday. Three businesses had been affected. The Township obtained an emergency permit from PennDOT, but only a small portion of the shoulder had been disturbed. A temporary patch would be in place until a permanent one can be put on in the spring. Mr. Lyon reported that the Pondview development had been sold and new agreements were being prepared with the new developer. The Manager stated we should soon have a tentative agreement with Service Electric to review. The Manager reported that almost all the right of way agreements for the Monocacy Interceptor had been sent to the property owners. We had received two back executed. Heritage would like to have a status meeting to review their development's status. Mr. Lyon stated he could put

together an updated status report after the meetings with the involved property owners had been concluded and then send it to Heritage. He didn't see the necessity for a meeting until the meetings with property owners are concluded.

Mr. Lyon reported that the developer for Arbour Green would probably be coming before the Board to review and discuss the required improvements to the existing sewer line. *Chief of Police* The Chief requested to attend a Civil Service Workshop. Mr. Yanos moved, seconded by Mrs. McGrath to approve. Motion passed 5-0. Mr. Yanos moved, seconded by Mrs. McGrath to send the three corporals and the Chief to "Advanced Supervision School" at \$360 per person plus meals and mileage. Motion passed 5-0. Mrs. McGrath asked if there would be sufficient coverage with four officers gone at one time. The Chief stated that a senior officer would be in charge.

Supervisors Mr. Yanos asked if the Board wanted to reopen the Budget. Mr. Weller stated that he was concerned about using the Township's reserves to balance the budget. He stated that next year the Board will have to raise taxes. Mr. Gokey stated that the Township still would have a million dollars in reserve, but he was concerned about the transfer tax. Mr. Stepp stated that if the Township had the money it should be used instead of raising taxes. Mr. Yanos stated he was concerned about the condition of the Township's roadways. He stated he would like to be conservative with legal expenses and would like to increase recycling revenues. He also stated he would like to have a strategy session at some point to outline goals and objectives. Mr. Gokey stated that perhaps the Board members could put together their own goals in anticipation of this strategy session.

Mr. Gokey stated he thought the Board has the makeup to go in the same direction and he hoped to position Amity as the business friendly township in Berks County. By soliciting more economic development to the Township, the tax burden could be decreased.

#### **PUBLIC COMMENT**

Risa Marmontello asked if yard waste was counted towards the recycling grant. Mrs. McGrath stated it was counted but not credited towards the grant. Mr. Yanos stated he would like to collect all the glass in the Township. Mrs. McGrath stated that they were working on the Fire Companies.

Terry Jones asked about the SMO ordinance. He stated that his neighbors are unclear about what is going on. Mr. Weller stated that the letter that was sent out was very clear.

#### **EXECUTIVE SESSION**

The meeting was adjourned to executive session to discuss administrative wages, and personnel issues at 8:45PM on motion by Mr. Stepp, seconded by Mr. Yanos, and duly passed.

The meeting reconvened at 9:25PM. Mr. Stepp moved, seconded by Mr. Weller to approve a 2.75% wage increase for non-uniform, non-contract (non-collective bargaining) employees for 2008. Motion passed 5-0. The increase is consistent with the 2008 budget.

# ADJOURNMENT

Being no further business, Mr. Stepp moved, seconded by Mr. Weller to adjourn the meeting at 9:26PM. Motion passed 5-0.
