The Board reviewed the Overtime by Department Report and had no questions.

#### REPORTS

**Code Enforcement** - Mr. Loomis reported approximately 49 properties are still non-compliant with the SMO inspections. Mr. Weller asked why the hearing was set for June for property maintenance issues that remain at 8 Riga Lane. Mr. Loomis stated the pallets were all removed and three "sea boxes" remain on the property. The owner of the property is exploring other alternatives such as erecting a structure to provide additional storage and remove the sea boxes.

**Road Department** - Mr. Weller questioned what happened to the Leaf Vac. Mr. Howell-Clarke replied that the hydraulic pump for the arm was replaced. The computer board also went bad. Leaf collection was completed by hand in December.

Waste Water Treatment Plant - Mr. Wheeler reported Wexcon finished the sewer line repairs in Amity Gardens. Wexcon will be back in the spring for repaving. Mr. Howell-Clarke stated he will be monitoring the repaving. Mr. Wheeler reported the lining company will continue working over the new few weeks. Mr. Weller asked if the aerators were installed. Mr. Wheeler explained the aerators will be installed in the spring, once there is no chance of freezing temperatures.

## **SOLICITOR'S REPORT**

A copy of the proposed amendment to the SALDO Ordinance regarding *recreation fees* was submitted to the Berks County Planning Commission (BCPC) for comments. Mr Musheno reported the BCPC had one minor comment to make a language change. The BCPC felt the word "and" in Section 519(c)(12) implied that agricultural land development would offer an additional 0.001 acres of land for dedication to the 0.006 acres for nonresidential land developments. If the intention was to provide minimum acreage requirements for the three different types of land development the BCPC recommended changing the language from "and" to "or"; or adding a period at the end of each requirement. The advertisement for the adoption of the proposed amendment must be done twice, with the second advertisement being done seven days prior to enactment. Mr. Musheno requested permission to advertise for consideration of the amendment at the first meeting in February.
