February 5, 2020

Call to Order/Pledge to the Flag

The February 5, 2020 meeting of the Board of Supervisors, held at the Township Municipal Building, 2004 Weavertown Road, Douglassville, Berks County, Pennsylvania, was called to order at 7:00PM by Chairperson Kim McGrath. The following were in attendance:

MINUTES

Mr. Keifrider moved, seconded by Mr. Weller to approve the January 15, 2020 minutes. Motion passed 4-0.

FINANCE

Mr. Hackett moved, seconded by Mr. Keifrider to approve the disbursements as follows:

- \$ 48,750.71 General Fund
- \$ 6.075.31 Fire Fund
- \$ 35,808.12 Sewer Fund
- \$ 55,238.41 EDU/Capital Fund

Motion passed 4-0.

The Board reviewed the Overtime by Department Reports and had no questions.

REPORTS

Codes – Mrs. McGrath asked Mr. Loomis to evaluate the accumulation of rubbish that can be seen through the trees on Monocacy Hill Road when entering via Limekiln Road. The rubbish and old vehicles are visible to neighboring properties' backyards. Mr. Weller asked for an update on the NOV for 107 Monocacy Hill Road. Mr. Loomis stated the owner and tenant requested an extension on remediation until spring of 2020, allowing them time to hold an auction and gain compliance. Mr. Loomis stated he granted the request until June 21st, which is the last official day of spring. Mr. Weller stated a sign for Amity Commons remains onsite at the Windstream building by Parklane Plaza. Mr. Keifrider mentioned there is also a pizza sign on that property. Mr. Loomis reported receiving another 18 payments for SMO compliance. Mr. Keifrider stated it's nice to see less signs along SR422. Mrs. McGrath stated she's glad to see some of the properties being cleaned up around the Township.

Roads – Mr. Keifrider asked if the individuals who broke the **window slats at Community Park** have been identified. Mr. Moore responded they have not. Mr. Weller asked for an update on the Schmale Farm. Mr. Moore reported they were working on water bars and making progress. Mr. Moore reported a total of 424 **Christmas trees** were collected and chipped this year.

Waste Water Treatment Plant – Mrs. McGrath asked if the liner and concrete pad repairs were completed at the Lagoon. Mr. Wheeler stated repairs need to be done after 3 weeks or so of dry weather or will be scheduled for spring.

OLD BUSINESS

Limekiln Low-Pressure — Mr. Bingaman reported Barrasso completed the project. PennDOT completed final inspections and closed the HOP. With no need to hold funds for the project, Mr. Bingaman recommended executing the Certificate of Completion. Any remaining items would be covered under the maintenance bond. Mr. Weller moved, seconded by Mr. Hackett to accept and authorize execution of the Certificate of Completion. Mr. Bingaman stated the final payment has been issued and was listed in the disbursements. Motion passed 4-0.

Act 209 Committee – Mr. Bingaman reported eight individuals have agreed to serve on the Act 209 Committee. Mr. Hackett moved, seconded by Mr. Keifrider to adopt *Resolution 20-07* appointing Richard Almquist, James Elliott, Pete Wanner, Wayne Klein, Michael Tornetta, Kim McGrath, Paul Weller and Terry Jones as members of the Act 209 Committee. Mr. Boland stated the Committee meets the minimum requirements and qualifications. Motion passed unanimously.

ZHB Vacancy – Mrs. McGrath asked if the Supervisors had time to review the four letters of interest. After a brief discussion, the Board directed Mr. Bingaman to coordinate 15-minute meetings with each of the interested parties. The Board agreed to have two Supervisors and the Manager meet with them from 6:00pm to 7:00pm on February 19th. The Supervisors conducting the meeting will make a recommendation to the rest of the Board at the regular meeting that evening. Mr. Boland stated the meeting did not need advertised because only two Board members would be conducting the candidate interviews.

SOLICITOR

P&H Senesac – Mr. Boland stated P&H Senesac had removed approximately 173 dry tons of sludge and grit from the Lagoon when they determined that significantly less sludge and grit would be removed from the Lagoon than anticipated. At that time, they ceased work causing the Township to hire another contractor to finish the project. P&H Senesac sought damages in excess of \$75K and the two parties have agreed to settle for \$2,000.00. Mr. Hackett moved, seconded by Mr. Weller to

authorize execution of the Settlement Agreement and Release and authorize payment of \$2,000.00 to P&H Senesac, Inc. Motion passed unanimously.

NEW BUSINESS

Ronald Rhoads Zoning Variance – Brian Boyer, Boyer Engineering, stated his client owns the property at 383 Ben Franklin Highway West, Douglassville and plans to submit a plan for annexation of a portion of an adjacent residential lot to provide driveway access to the land-locked property if granted the variances requested. Mr. Boyer stated the annexation plan would create a Flag Lot and would not satisfy the requirements for driveway width. Mr. Weller moved, seconded by Mr. Hackett to send a letter of recommendation to the Zoning Hearing Board in favor of granting the variances as requested. Motion passed 4-0.

Resolution 20-08 — The Township applied for an additional Green Light Go Grant and is required to electronically access the PennDOT program to verify the traffic signal conditions. Mr. Bingaman was informed that Amity Township was never set up as a Political Subdivision, which would grant access to that program. In order to access that program, the Township must adopt a resolution and sign the proposed agreement, which advises that Amity Township is a Political Subdivision and identifies the users permitted access. Mr. Hackett moved, seconded by Mr. Weller to adopt Resolution 20-08, authorizing and directing execution of the Agreement to Authorize Electronic Access to PennDOT Systems. Motion passed 4-0.

Eastern Industries/New Enterprise Parcel on Hill Road – Mr. Keifrider inquired about the parcel owned by Eastern Lime Corp of PA (New Enterprise) A/K/A Eastern Industries. Mr. Bingaman reported reviewing the file from 2007 when the Township had interest in acquiring the property. The parcel was a former blacktop plant. Mr. Boland stated he recalled there was concern over who would be responsible for the environmental remediation. Mr. Bingaman spoke with a PADEP representative who said the property was not on their radar at this time and suggested a Phase II Environmental study and soil sampling completed to determine the parcel's status. An Act 2 clearance letter may be required to remove the wooded and paved areas. Mr. Boland stated testing would need to be done. The clearance would permit certain uses for the property. Mr. Keifrider stated the nearly 10-acre parcel abuts Monocacy Hill and is across from Hill Road from the Hill Road Park and could provide additional parking for both facilities. The Board was in agreement to move forward.

2019 DCED Statement of Financial Condition – Mr. Keifrider moved, seconded by Mr. Hackett to authorize electronic submission of the 2019 Statement of Financial Condition. Motion passed 4-0.

Manager's Report

Drainage Issues Along SR422 – Mr. Bingaman reported a February 10th conference call will be held with PennDOT.

IPMC Appeals Board – Mark Sheeler (local builder), Aaron Baum (building contractor) and Richard Almquist (business owner/property manager/developer) have all agreed to serve on the IPMC Appeals Board. Mr. Boland stated he would have a resolution prepared for the February 19th meeting.

Summer Playground Program – Mr. Bingaman presented the idea of having the Reading/Berks YMCA run the program to the Parks and Recreation Board and they had no negative comments. Mrs. McGrath moved, seconded by Mr. Keifrider to authorize the Reading/Berks YMCA run the 2020 Summer Playground Program. Motion passed 4-0.

Manhole Repairs on SR662 – Mr. Bingaman reported the three manholes have been repaired. Final paying will be completed in the spring.

Chief of Police Report

Officer Santiago attended a seminar on *Medical Marijuana* in Allentown. Chief Smith said the training covered topics such as handling traffic when a driver has a Medical Marijuana Card. Mrs. McGrath asked if Officer Santiago shares that training with the rest of the department. Chief Smith stated he does, but it is not required. Chief Smith reminded residents to *lock their vehicles*. Thieves are targeting vehicles that are left unlocked.
