# Amity Township Board of Supervisors <u>Meeting Minutes</u>

December 16, 2020

### Call to Order/Pledge to the Flag

The December 16, 2020 meeting of the Board of Supervisors was held via Zoom, a cloud platform for video and audio conferencing, and was called to order at 7:00PM by Chairperson Kim McGrath, followed by the pledge to the flag. The following were in attendance:

#### ANNOUNCEMENTS

Mrs. McGrath announced that on December 15, 2020, Governor Wolf proclaimed a *Disaster Emergency* in 57 of the 67 counties in Pennsylvania in advance of the severe winter weather event forecasted to bring snow, ice and flooding.

#### **MINUTES**

Mr. Weller moved, seconded by Mr. Keifrider to approve the December 2, 2020 minutes. Motion passed 4-0.

#### **FINANCE**

Mr. Hackett moved, seconded by Mr. Keifrider to approve the disbursements as follows:

The Board reviewed the Overtime by Department and November Treasurer's Reports and had no questions.

### REPORTS

*Fire Companies* – Supervisors reviewed the Amity and Monarch Fire Company Reports and had no questions.

Planning Commission – Mr. Weller moved, seconded by Mr. Hackett to accept the 90-day time extension for the Monocacy Hill Investment, LLC minor subdivision plan. Motion passed 4-0. The 90-day extension will expire on April 21, 2021. Mr. Weber stated the Planning Commission accepted the Arbour Green Preliminary Plan for review. The Arbour Green Plan is a commercial retirement home development plan with 148-age-restricted apartments. The Planning Commission reviewed the concept sketch plan for Highland Place, a 337-unit age-restricted development on the Flatley property (Amity Park Road). Mr. Weber stated the developer intends to submit a fully engineered plan in February 2021.

#### **OLD BUSINESS**

None

## **SOLICITOR**

Mr. Boland had nothing to report.

#### **ENGINEER**

Mr. Weber reported the new building at *Moove In Self Storage* is nearly finished. Paving and stormwater controls need to be completed, but it's anticipated the new buildings should be opening in spring of 2021. Mr. Weber reported the concrete and curb work is being done in preparation for paving at *Jiffy Lube*.

#### **NEW BUSINESS**

Zoning Variance for 2 non-conforming lots, Monocacy Hill Investment, LLC – Mr. Weber stated property is located at 391 Monocacy Hill Road, in the PBOI zoning district and is being subdivided into two non-conforming lots. The minimum lot size in the PBOI is 40-acres. Mrs. McGrath asked what the acreage would be for each lot. Mr. Weber stated Lot 1 would be 22.9 acres and Lot 2 would be 38.7 acres. Jamie Keith, Boyer Engineering, stated the plan is in its infancy stage. The existing house on Lot 1 will be demolished and the new house is planned to be built in approximately the same location. Mr. Boland stated the proposed lot lines would leave the septic system on Lot 2 and the Planning Commission made a recommendation to approve the variance conditioned upon the new house on Lot 1 being connected to public sewer, if Lot 2 is sold and a new house is constructed on Lot 2 that house must connect to public sewer, ensuring the lots do not share the existing septic system. Mr. Keifrider moved, seconded by Mr. Weller to send a letter to the Zoning Hearing Board in favor of granting the variance, with the same conditions set by the Planning Commission. Motion passed 4-0.

*Elected Auditor Vacancy* – Mr. Bingaman stated Curtis Clifford works at a polling place for the elections and was unable to fulfil his term as an Elected Auditor, which left the vacancy. When Mr. Clifford resigned in 2020, the Board chose to not seek a candidate to fill the vacancy. *Bruce MacGregor*, 215 Spring View Drive, expressed an interest in filling the vacancy. Mr. Bingaman stated the appointment would be through the end of 2021 at which time Mr. MacGregor could

petition to be listed on the ballot. Mr. Keifrider moved, seconded by Mr. Weller to appoint Bruce MacGregor as auditor through December 31, 2021. Motion passed 4-0.

*Authorize Advertisement of 2021 Meeting Dates* – Mr. Keifrider moved, seconded by Mr. Weller to authorize advertisement of the 2021 meeting dates, as proposed. Motion passed 4-0.

MANAGER'S REPORT – Mr. Bingaman reported our part-time maintenance worker *S. Michael Shaffer*, gave notice that his last day would be January 8<sup>th</sup>. Mr. Bingaman stated Mr. Shaffer worked 24.5 hours per week cleaning buildings and parks. The position is a union position without benefits. Mr. Bingaman stated staff will put notice out to fill that position going forward. Mr. Bingaman received an email from the DCED *Greenways*, *Trails and Recreation Program (GTRP)* seeking additional clarification for the grant application. Mr. Bingaman stated this could be a good indication they are getting close to awarding the grant. If awarded the GTRP grant, it would provide the matching funds for the DCNR grant previously awarded for the complete rehabilitation of Lake Drive Park.

#### CHIEF OF POLICE REPORT

Chief Smith stated the Memo of Understanding (MOU) regarding Section 106 (D) was issued to clean up language in the Collective Bargaining Agreement and would allow more efficient staffing of shifts. Chief Smith stated the revisions made by Mr. Boland would need to be approved by the Police Association before seeking Board approval. Approval of the MOU was tabled to the January 4th Reorganization meeting. Chief Smith asked if the Manager received the *updated run cards*. Mr. Bingaman stated he had not received them as of the time of the meeting. Chief Smith stated he would contact Antony Tucci, Western Berks, for a status update. Western Berks representatives toured 888 Old Airport Road and would be interested in making that location their permanent station within the Township. Chief Smith stated a meeting would be necessary to discuss the Township leasing the property and drawing up a lease. Chief Smith stated Western Berks has a tentative start date of January 4th to begin offering *primary EMS* services within the Township, temporarily operating out of Amity Fire Company. The Chief stated Western Berks has purchased additional radios to provide coverage in Amity and surrounding Townships that were part of the SBREMS footprint. Per Berks DES, Amity Township paid 17.9% of the total cost for SBREMS radios. After a short discussion, due to depreciation the Board agreed it was not worth obtaining any of the existing SBREMS radios.

#### **SUPERVISORS**

Mr. Keifrider reported the judges spent the last three days judging the houses that were entered into the *Holiday Decorating Contest*. A list of the winners will be published on Monday. Mr. Keifrider stated it was great to see the level of participation and competition in various neighborhoods. Mr. Bingaman encouraged everyone to take a drive around and view the many spectacular light displays throughout the Township.

**Declaration of Disaster Emergency** – Mr. Weller moved, seconded by Mr. Hackett to adopt **Resolution 20-35**, a Declaration of Disaster Emergency in Amity Township as a result of the predicted severe winter event. Motion passed 4-0.
