# August 17, 2022

# Call to Order/Pledge to the Flag

The August 17, 2022 meeting of the Board of Supervisors held at the Township building, 2004 Weavertown Road, Douglassville, Berks County, Pennsylvania, was called to order at 7:00PM by Chairperson Kim McGrath, followed by the pledge to the flag. The following were in attendance:

<u>VISITOR</u> – Jim Tucker, of Woodbridge Lane, emailed the Township voicing his concerns and frustrations on the condition of open space behind his home due to ash trees being cut down and left lay for nature. Mr. Tucker stated the area has since been cleaned up, as well as with his neighbors. He noted there are seven houses in the cul-de-sac that back up to Old Airport Road that have open space behind them and are maintained, however, he never had his property surveyed and thought it was part of his lot. He stated when they took the ash trees down, it became more of an eyesore and hazard, as his kids have played in that area for the last seven years, and he became frustrated. He was informed the Township had to maintain a certain amount of open space for 20 years, noting the neighborhood is now more than 20 years old and is asking if there is any possibility of purchasing the open space area, as he would like to install a fence and pool on the property. Mr. Boland explained the Township has looked into unloading open space in the past, however, it would require a massive sub-division and more importantly; we have a restriction on open space that states it's given to the Township as permanent open space, so there is nothing the Township can do; we are stuck with the open space, as well as maintaining it. Mr. Keifrider noted he understood and has the same situation on his property; you can use it but cannot build on it.

Mr. Jones moved, seconded by Mr. Weller to approve the July 20, 2022 Minutes. Motion passed 5-0.

Mr. Jones moved, seconded by Mr. Weller to reaffirm the *August 3<sup>rd</sup> disbursements* as follows:

Motion passed 5-0.

The Board reviewed the *Overtime by Department Reports* and *June 2022 Treasurer's Report* and had no questions.

#### REPORTS

*Fire Companies* – Chief Mike Zomolsky, from *Amity Fire Company*, read his July Run Report, noting there were 55 incidents. Financials for Amity were submitted on the workspace. Chief Zomolsky reported they are applying for a State Grant, working on the close-out for 2021-2022 and being audited on the State Grants received in 2019, 2020 and 2021.

Representatives from *Monarch Fire Company* were not present at the meeting; however, incident and financial reports were provided on the workspace. There were no questions.

*Western Berks EMS* – Representatives from WBEMS were not in attendance. The Board reviewed the July report and had no questions.

**Planning Commission** – Mr. Weber reported there were two Time Extensions; **Highland Place** –Mr. Jones moved, seconded by Mr. Weller to accept the Extension of Time to 11/16/2022. Mr. Keifrider abstained. Motion passed.

447 Old Swede Road – Mr. Weller moved, seconded by Mr. Hackett to accept the Extension of Time to 1/18/2023. Motion passed 5-0.



Mr. Bingaman reported; no one was present from *Bogia Engineering Inc.*; therefore, he reported on behalf of *NorthPoint Development*, who is asking for a consideration on a reduction of their initial escrow amount for Plan Review. The calculation by our Fee Schedule would require them to post \$96,500.00. They're requesting to post an initial amount of \$25,000, with funds being replenished upon notice of the Township when they've reduced to 10% or less. Mr. Bingaman noted he felt \$50,000 would be more palatable to us, with a replenishment at \$5,000 to \$10,000. Mr. Weller asked how the calculation was figured at \$96,500. Mr. Bingaman noted it was based on square footage of the buildings. Mr. Bingaman stated; after meeting with PennDOT, there will be significant challenges for the project and we need a sufficient escrow. Mr. Jones moved, seconded by Mr. Weller to approve a \$50,000 initial amount of escrow, replenishing at \$10,000. Motion passed 5-0.

Codes – Mr. Jones asked if anything was resolved on sewer for *Moorhouse*. Mr. Loomis stated they are working on a design and will resubmit to Mr. Weber. Mr. Loomis also reported the shrubs have been trimmed on *Pinewood* and the cicada killers are down on *Old Airport Road*. Mr. Jones mentioned the access on *Worman Road* has not yet been cut and it's well over two foot tall. Mr. Keifrider noted the *property at Loyalsock and Old Airport Road* has about twenty pieces of equipment sitting on the property and asked Mr. Loomis to make sure he is not running an excavating business. Mr. Jones mentioned that resident is retired and doesn't have a business. Mr. Loomis stated he will look into it. Mr. Loomis mentioned; permits keep coming in and we are about 45 permits more than last year at this time. Normally it slows down about July, but hasn't.

**Roads** – Mr. Jones asked how much salt we wound up getting. Mr. Maguire stated, roughly about 12 truckloads. Mr. Maguire also reported they milled all of Lake Drive today. Mr. Weller asked about the stormwater replacement on Levengood road and what we're putting in. Mr. Maguire noted PVC and it will be an open culvert. Mr. Keifrider asked the condition of the skate park equipment. Mr. Maguire stated it's not in good shape. Mr. Keifrieder asked if we're putting it back down. Mr. Bingaman stated we plan to; it's very expensive, so we will see what the installer has to say. Mr. Weller asked if it could be refurbished. Mr. Maguire stated it could be with some welding, however he voiced concerns over moving the equipment back and ruining the macadam since it's soft. Mr. Bingaman noted we will be installing two or three new pieces we approved, so we could just put that down. Mr. Keifrider stated; we should choose what is salvageable, so we don't ruin the surface. Mr. Bingaman stated, the Levengood Storm Sewer Replacement is an emergency, as the road is eroding away. After a brief discussion as to what work needs to be done, Mr. Bingaman stated, we have \$25,000 budgeted and would need to dip into the Capital Fund for the balance. Mr. Maguire also referred to the second job, which is down by the winery. He is waiting on a quote, and it will be put into the 2023 budget. Mr. Bingaman added, that one is not an emergency and will be bid out. Mr. Jones asked if we could buy the pipe awhile for the second job, which he feels would lower the cost when bidding out, making it more manageable. Mr. Jones moved, seconded by Mr. Keifrider, to accept the proposal from Barrasso Excavating and take the balance, over \$25,000, out of the Capital Fund. Motion passed 5-0.

Waste Water Treatment Plant – Mr. Jones asked about the camera truck and the price. Mr. Maguire stated they will give him two prices; one with a camera head and one with a lateral camera launcher, adding; it will be close to \$120,000. I should have those quote within the next two months and it will include the installation. Mrs. McGrath asked about the connection with the Racehorse Association. Mr. Bingaman explained; along with Westmoreland, York County and Berks County, we have the ability to apply for Grants that are tied to a racehorse venue, which is where the money comes from to fund the Grants.

#### **OLD BUSINESS**

Park Lane Hobbies – RC Race Car Track Update – Mr. Keifrider reported; since getting a favorable feeling from the Board, I said they should move forward with a drawing and answer any questions. Mr. Jones had mentioned to look at the ballfield behind the salt shed, since it's unused. Ms. Grasso felt it would meet their needs. A discussion on the printout/plan they have so far, including where they would place asphalt and dirt was held. Mr. Keifrider asked if this will trigger storm water and Mr. Loomis figured the asphalt would, not the dirt. Mrs. McGrath stated they will need an approved plan to show where the water will flow, how it will drain, so as to not contaminate anything. There was a discussion on the run-off and what their next steps would be. They will contact a Civil Engineer to draw up something to meet the guidelines.

<u>BCCD Memo of Understanding</u> - Mr. Jones moved, seconded by Mr. Keifrider to approve the amended BCCD Memorandum of Understanding. Motion passed 5-0.

## **SOLICITOR**

Lotting Exclusion – Setbacks Ordinance - Mr. Weller moved, seconded by Mr. Jones for approval to forward the Ordinance to the Berks County Planning Commission for review. Motion passed 5-0.

Hospitals in Highway Commercial - Mr. Boland stated they just sent out a draft of this today and it still needs review and revision.

# ENGINEERS LTL CONSULTANTS

Hill Drive Stormwater – Mr. Weber reported there is a site meeting set for August 30, 2022, with the two property owners on the lower side of Hill Drive whose properties are most impacted.

### Moove-In Self Storage Escrow Release # 3

Mr. Jones moved, seconded by Mr. Weller to approve Escrow Release #3 in the amount of \$18,687.05 in accordance with the recommendation of LTL Consultants. Motion passed 5-0.

## Amity Square Project on Park Lane Escrow Release # 2

Mr. Weber reported the detention basin was installed, the parking area was paved, although it still needs a final wearing course. Mr. Weller moved, seconded by Mr. Keifrider to approve Escrow Release #2 in the amount of \$34,525.01 in accordance with the recommendation of LTL Consultants. Motion passed 5-0.

Mr. Weber also reported; Lake Drive was milled today and is scheduled for paving between September 1<sup>st</sup> and September 6<sup>th</sup> and will need to cure for two weeks. The project is moving along.

# ENTECH ENGINEERING

Mr. Miller was not present.

#### **NEW BUSINESS**

## Artistic Visions Wildlife Studio

Mr. Jones moved, seconded by Mr. Weller to approve the waiver from the Stormwater Management Section 312C, due to a substitution of materials and to not require a concrete end section to the piping. Motion passed 5-0.

Mr. Bingaman noted; items 2 through 5 on the Agenda should reflect Zoning Variances, not Zoning Waivers; as the Agenda states.

#### Horvath

Mr. Weber addressed the Board on behalf of Steven Horvath, of 212 Pleasant View Rd, recommending the Zoning Hearing Board grant relief from Zoning Section 902(b)(9), to build a garage 176 square feet larger than the 500 square feet allowed. After a discussion, Mr. Weller moved, seconded by Mr. Jones to recommend favorable action. Motion passed 5-0.

#### 447 Old Swede Road

Mr. Weber addressed the Board recommending the Zoning Hearing Board grant relief from Section 407 (e), to allow the construction of the building addition, which would increase the impervious coverage to 62.5% (2.5% over the limit), with regards to 447 Old Swede Rd – Preliminary Plan Warehouse Expansion. After a brief discussion, Mr. Weller moved, seconded by Mr. Keifrider to recommend favorable action. Motion passed 5-0.

# Leaf Creek Farm/Northampton Farms, LLC

Kevin Kruck, from Cornerstone Consulting, addressed the Board to recommend the Zoning Hearing Board grant a Variance for a 6,100 square foot Community Center, including Pickleball Courts. Mr. Weller moved, seconded by Mr. Keifrider to recommend favorable action. Motion passed 5-0.

Mr. Keifrider moved, seconded by Mr. Weller to recommend the Zoning Hearing Board grant a Variance for setbacks of *Paved Terraces*, *Patios and Open Patios*. Motion passed 5-0.

Mr. Jones moved, seconded by Mr. Weller to recommend the Zoning Hearing Board grant a Variance for the location and setbacks of a *Community Center Parking Lot*. Motion passed 5-0.

## Michael Zomolsky

Michael Zomolsky, 5 Pine Lane Court, is requesting the Zoning Hearing Board grant a Variance allowing him to build a 28 X 28 pole barn garage, placing it one foot from the rear property line, 10 feet from the side property line and to allow the garage to be built at a height of 21 feet 6 inches. Zoning allows a height of 20 feet. After a brief discussion, Mr. Jones moved, seconded by Mr. Keifrider to recommend favorable action. Motion passed 5-0.

# Adopt Amended Health Insurance Plan Document - Length of Service Required

After a discussion, Mr. Weller moved, seconded by Mr. Keifrider to approve amending our health insurance plan document to allow flexibility in waiving the waiting period for new employees. Motion passed 5-0.

<u>MANAGER'S REPORT</u> – Mr. Bingaman reported Will Brugger, Exeter's Zoning Officer, reached out to inquire if Amity would want to consider budgeting in 2023 for an update to the *Joint Comprehensive Plan*. Our Plan is dated and should be updated every 10 years. Mr. Bingaman reached out to Berks County Planning Commission. They are willing to help us with the process and will provide us with a quote. Mr. Weller asked if we are paying this time. Mr. Bingaman stated the previous funding stream has been depleted. The Board wishes to review the quote and any information before any agreement is made.

*NorthPoint Development PennDOT Scoping Application* - We did have a PennDOT Scoping Meeting with NorthPoint Development regarding the Amity Logistics Center. There are concerns with the intersections of; SR 422 and Township Line, SR 422 and Riverbridge and Tollgate and SR 662. There is a lot of work ahead on this project.

*Neighborhood Hospital* – we did get official word from Attorney Orlando that the plan for the Neighborhood Hospital would be a taxable business.

Comcast Xfinity Network Expansion – Comcast has submitted a draft Franchise Agreement. Going back into the records there is no Franchise Agreement we could find executed by Comcast, adding; Comcast didn't find one either, but the Board approved it in 2014. They have provided a draft and revisions have been made, which will be provided to the Board after Mr. Boland's review. Mr. Jones stated, Comcast will provide high speed internet to municipalities, so get that put in the agreement. Mr. Bingaman stated they said that is not included; the free service is only for cable. Mr. Jones noted; they have to run it into the building to take advantage of it.

Sale of Personal Property Under \$2k - Mr. Bingaman reported; Section 1504 (b) in the Second-Class Township Code states the Board shall, by Resolution, adopt a procedure by which personal property may be sold without further action by the Board of Supervisors. We have items at 888 Old Airport Road which we need to get rid of but have a value of less than \$2,000. He asked Mr. Boland what our next step for this procedure would be. Mr. Boland stated, to designate it as surplus property, directing the administration to dispose of the same. Mr. Weller moved, seconded by Mr. Keifrider to approve adopting a procedure agreeable with the guidelines to disposing of surplus property valued at less than \$2,000 in the Second-Class Township Code. Motion passed 5-0.

Mr. Bingaman reported he's been receiving calls from residents that they've received *delinquent tax notices*, but they've never received a bill in March. Property owners with County/Township Real Estate Taxes that have not yet been paid for 2022 have been sent delinquent notices. The County said they will accept them at flat rate if we will. After a discussion, the Board did not desire to set a precedent by accepting at the flat rate for delinquent taxes.

888 Old Airport Road – Mr. Boland commented; we started out with the Conditions of Sale and wanted to reference the parcel numbers, noting there are two parcel numbers. The parcel numbers and deed descriptions were also checked, and the descriptions were inaccurate. There was a lot of time spent rebuilding the descriptions and it's now been recorded with a clean description of the Old Airport Road land and the Community Park. Mr. Bingaman stated, we have a Farm Lease in the back and a letter was sent to Mr. Richards asking after he's harvested this year's crop would he be willing to terminate the lease. The lease expires 12/31/2023.

Mr. Bingaman requested an Executive Session to discuss personnel matters, real estate and potential litigation.

Mrs. McGrath asked if Mr. Bingaman knew anything about someone teaching at the pickleball courts. Mr. Bingaman noted; we have told the individual they need to apply for a permit and pay the associated fees from the Fee Schedule. He added; we can't prevent anyone from playing up there and inviting people, however when they are charging for it and using our facilities, they need to pay according to the Fee Schedule and obtain a permit.

#### CHIEF'S REPORT

Chief Smith reported; the new busing company will be using *BusPatrol*, having cameras on the stop arm signals when the lights are on and the arm is extended. The camera captures a picture of the vehicle and license plate that is forwarded to us via email with a time stamp. If we elect to use that, under Section 3345.1 of the PA Motor Vehicle Code, it is a civil violation. After addressing a few concerns with BusPatrol and a discussion on the regulations; a motion by Mr. Jones, seconded by Mr. Keifrider to approve the agreement, subject to final review and approval of the Solicitor. Motion passed 5-0.

*Operation Nighthawk* – Officer Devlin participated. There were two other Officers working Friday night, all three had DUI's within a half hour of each other.

Chief Smith also reported we received an *Occupant Protection Grant* for \$1,000, which is like the Buckle-Up program.

Mr. Jones asked about the number of school buses parked at the Middle School, noting there are no buses allowed to park or be stored there 24/7, according to the Zoning District. The parking lot is for loading and unloading of school buses. Mr. Loomis said he will check on it.

#### **SUPERVISORS**

Mr. Keifrider reported *Harvest Fest* is pretty much set. Nellie, from Park Lane has offered to help with fundraising.

Mr. Keifrider also mentioned; the reason we are selling 888 Old Airport Road and the property adjacent, is to potentially build another building or garage for storage. He suggested starting the process now and check prices to know how long the process will take and what we want to do. Mr. Bingaman stated, if we're continuing with the plan we had, we do have a draft of a design and most likely it will have to go out for bid. There was a discussion on ideas of what is needed. Mr. Jones stated he thought they were tearing down the salt shed to build a building storing the equipment inside. Mr. Bingaman added; and to store records, as we are out of room. Mr. Boland suggested checking the chart to see what we can scan and get rid of with regards to records.

#### **PUBLIC COMMENT**

Mr. Cooper, Limekiln Rd – voiced his concerns with regards to the recycling contract and possibly lowering the cost. Mr. Bingaman stated we are currently being paid per ton for material, however the costs will likely go up significantly and we will have to pay to dispose of materials in the future. There was a discussion on recycling pick up.

*Mr. Gans, Rising Sun Drive* – asked about the old Charlies building, hearing it would be torn down to be replaced with an apartment complex. The Board stated they have not seen any plans.

# EXECUTIVE SESSION AND ADJOURNMENT

At 8:47PM, with no further business, Mr. Keifrider moved, seconded by Mr. Jones to adjourn to *Executive Session* to discuss personnel matters, real estate and potential litigation, with no need to return.

Meeting adjourned at 8:47PM.


