The February 15, 2023 meeting of the Board of Supervisors held at the Township building, 2004 Weavertown Road, Douglassville, Berks County, Pennsylvania, was called to order at 7:00PM by Chairperson Kim McGrath, followed by the pledge to the flag. The following were in attendance:

ANNOUNCEMENTS

Mrs. McGrath announced the *agenda was amended* to add Conditional Preliminary Plan Approval for Vincenzo's Ristorante and Plan Reaffirmation for Royal Farms to the Planning Commission report. Mr. Jones moved, seconded by Mr. Weller to adopt the amended agenda. Motion passed 5-0.

PUBLIC COMMENT (AGENDA ITEMS ONLY)

None

MINUTES

Mrs. McGrath stated the Regular Meeting minutes should be changed to reflect the pool needed to be 15-foot from the side yard, where a 25-foot setback is required. Mr. Jones moved, seconded by Mr. Hackett to approve the *January 18th Conditional Use Hearing minutes*, and the *January 18th Regular Meeting minutes* with the change requested by Mrs. McGrath. Motion passed 5-0.

FINANCE

Mr. Jones moved, seconded by Mr. Hackett to reaffirm the February 1st disbursements as follows:

Motion passed 5-0.

The Board reviewed the *Overtime by Department Reports* and *January Treasurer's Report* and had no questions.

REPORTS

Fire Companies – Chief Zomolsky provided a verbal report for Amity Fire Company. The Board reviewed the Monarch Fire Company reports and had no questions. Representatives from Monarch Fire Company were not present.

Western Berks EMS – Representatives were not present. Mrs. McGrath noted there were 130 total calls, of which 90 were transports.

Planning Commission – Vincenzo's Ristorante Annexation Preliminary Plan – Brian Boyer, Boyer Engineering, reviewed each of the waivers being requested. Planning Commission recommended granting the requested waivers. Mr. Weber stated he was fine with the waivers. Mr. Keifrider moved, seconded by Mr. Jones to grant waivers for Section 507(a)(3), Section 517(d)(2)(v) and Section 307. Motion passed 5-0. Mr. Weller moved, seconded by Mr. Hackett to grant Conditional Preliminary Plan Approval subject to meeting all conditions set forth in the LTL letter dated 2/2/2023. Motion passed 5-0. 209 Monocacy Creek Road – Mr. Jones moved, seconded by Mr. Weller to accept the time extension to 6/22/2023. Motion passed 5-0.

Codes – The code report stated there were multiple complaints from residents who were charged \$300.00 to \$450.00 to have sewer laterals televised. Mr. Loomis requested the Board discuss the possibility of purchasing a **TV camera** to have WWTP staff record each video. As Mr. Loomis was not present, the Board would address that matter later in the agenda under the WWTP report.

Roads – The Board reviewed the Road department report and had no questions.

Waste Water Treatment Plant – Mr. Maguire reported the new generator is inside the building at PS4. Conduit was installed and wired. Mr. Maguire stated they are waiting on exhaust brackets. Once received, a Koehler representative will perform the first start up and load bank test. The portable generator will be returned to Fisher Rentals once the new generator is up and working. Mr. Loomis recommended the Township purchase a TV camera to perform lateral inspections, as many residents are complaining of paying companies between \$195.00 to \$475.00. Mr. Maguire stated if the Township wanted to perform the inspections, his recommendation would be to purchase a lateral camera that has the ability to record data for each inspection, as well as the capability of line detection for above ground purposes because the Township has no blueprints for laterals. Mr. Jones stated he feels the Township should have that equipment for Township purposes only. Mr. Jones

stated he disagrees with entering private property to inspect the owner's laterals. Mr. Bingaman stated residents are currently provided a list of companies that provide those inspections. Mr. Maguire reported they are still waiting for delivery of the new pressure relief and flame trap assembly for the *heater in the Anaerobic Digester Building*.

OLD BUSINESS

TowerDIRECT Appointment and Agreement – Mr. Bingaman stated Brad Cosgrove indicated he didn't believe the Board of Directors would have any issues with the agreement as presented, however, Mr. Bingaman had not heard back as of yet. Mr. Jones moved, seconded by Mr. Weller to approve the agreement as presented with TowerDIRECT and subject to final review by the Manager and Solicitor and appoint TowerDIRECT as the EMS provider in Amity Township, effective 3/15/2023. Motion passed 5-0.

Park Lane Hobbies – Mr. Boland stated he started revising the Operations and Maintenance Agreement earlier in the day. Mr. Keifrider moved, seconded by Mr. Hackett to approve the Operations and Maintenance Agreement subject to final Solicitor's review. Motion passed 5-0.

Volunteer Firefighter Tax Incentive Parameters – Mr. Jones moved, seconded by Mr. Keifrider to adopt **Resolution 23-04** establishing parameters for eligibility to receive the tax incentive. Motion passed 5-0.

Royal Farms – Mr. Boland reported he spoke to the Royal Farms counsel earlier in the day and they are hopeful they will have the PennDOT HOP tomorrow. Municipal Improvements, Stormwater and Financial Services Agreements are ready for execution and bond has been posted. Mr. Weller moved, seconded by Mr. Hackett to authorize execution of the agreements. Motion passed 5-0. Mr. Jones moved, seconded by Mr. Weller to adopt Resolution 23-05, reaffirming Plan Approval for Royal Farms. Motion passed 5-0.

SOLICITOR – Mr. Boland stated the MB Investments / Santora's Repair Conditional Use Hearing was held January 18th. Mr. Boland reviewed each of the conditions set in the Decision and Order, including the limit of no more than (30) vehicles being on the entire property in combination with Dotterer's repair facility. That provision specifically modifies the Conditional Use Order and Decision of October 15, 2014. Mr. Keifrider asked if Condition #13 should be amended, because as written, all vehicles on the property that aren't being repaired, not even those driven to work by the owners, would be in violation. Mr. Boland clarified that condition was aimed at compliance of storing vehicles. Mr. Keifrider moved, seconded by Mr. Hackett to adopt the Findings of Fact, Conclusions of Law, Order and Decision as presented. Motion passed 5-0. Lake Drive Park Rehabilitation Project – Mr. Boland asked the Board if they wished to take any action on the Construction Masters Services (CMS) demand for payment. Mr. Jones moved, seconded by Mr. Weller to direct the Township Manager to issue a response to CMS, rejecting their terms. Motion passed 5-0.

ENGINEERS

LTL CONSULTANTS – Artistic Visions Wildlife Studio – Mr. Weller moved, seconded by Mr. Hackett to approve Escrow Release No. 2 in the amount of \$48,451.25 in accordance with the LTL letter dated 2/9/2023. Motion passed 5-0. Amity Square Addition – Mr. Weber reported all required improvements were completed, as-built plans submitted and approved, and recommended approving Escrow Release No. 4 in the amount of \$14,618.11. Mr. Keifrider moved, seconded by Mr. Hackett to approve Escrow Release No. 4 per the LTL letter dated 2/10/2023 and subject to payment of all outstanding invoices. Motion passed 5-0.

Entech Engineering – Mr. Miller stated they are making good progress on the **WWTP Expansion design**. A meeting was held with the architect in respect to design of the control building. Mr. Miller stated he still needs to finalize the requirements for SALDO and whether they will be required to submit a formal land development plan. Mr. Weber stated he didn't believe it would require submission, but would be reaching out to Mr. Miller tomorrow.

NEW BUSINESS

Oz Group Inc, Moving / Extending Non-Conforming Uses Zoning Variances (Geiger Road) — Mark Koch, counsel for the Oz Group, stated the Zoning Hearing application was submitted in response to a NOV issued by Mr. Loomis. Zach Arnold stated the property consists of five or six parcels. Mr. Arnold distributed a sketch plan to the Supervisors and explained the proposed changes include a two-story professional office building, removing old structures and replacing with new buildings and updating the facades of buildings that will remain, all of which will ultimately improve the overall appearance of the property. Mark Koch, counsel for the Oz Group, stated Mr. Loomis would like the NOV dealt with in February, which is not possible with the requirements for the plan submission process. Mr. Koch stated he would like the hearing pushed back to March 23rd, giving them time for Planning Commission to review the plan on March 9th. Mr. Weber stated the plan could be accepted at the March 9th meeting, but the plan wouldn't be reviewed until the April 13th meeting. Mr. Boland agreed the hearing could be postponed for the land development process, because it makes sense. Mr. Boland stated the action wouldn't require a motion. Mr. Boland stated he would review the abeyance process for the NOV with Mr. Loomis. The Board did not take action on a ZHB recommendation.

<u>MANAGER'S REPORT</u> – Mr. Bingaman provided a recap of *2022 financials*. General Fund revenues exceeded budget by 7.7%, with expenses 4.6% under budget allowing \$722,900.00 to be transferred to the Capital Fund. Sewer Fund revenues exceeded budget by 5.7%, with expenses 2.1% over budget allowing \$450,000.00 to be transferred to the Sewer Capital Fund. The Fire Tax, Traffic Impact and State Liquid Fuels Funds were all healthy as well. The Recreation Fund has a negative balance of just over \$12K, which will become positive as soon as 447 Old Swede completes their planning process and pays associated fees with the land development. Only 78 properties were turned over to the Berks County Tax Claim Bureau for collection of *2022 Real Estate Taxes*, for a total of \$17,696.00.

2023 Real Estate Taxes will be based on the township-wide assessed value of \$733,148,300.00. Mr. Bingaman reported meeting with our new PA State Representative, Mark Gillen, who would like to begin offering sitting hours in the former Tax Collector office.

CHIEF'S REPORT

Chief Smith reported all interviews have been completed and the background phase of hiring for the full-time Police Officer opening has begun. Mr. Keifrider moved, seconded by Mr. Hackett to approve offering a *conditional offer of employment* to the top candidate, conditioned upon successful completion of the background investigation. Motion passed 5-0. Chief Smith reported the Police Department received a **\$50.00 donation** from Fred Saul.

SUPERVISORS

Mr. Weller reported meeting with *PA State Senator Tracy Pennycuick*. Sen. Pennycuick seemed genuinely interested in helping the Township find grant opportunities. Mr. Keifrider announced the *2023 Harvest Fest* will be held October 14th and 15th. The date was moved to the weekend after Columbus Day, to avoid conflicts with other scheduled events.

PUBLIC COMMENT

Denise Boyer, Old Swede Road, stated they received a letter from Boyer Engineering in which they proposed moving their driveway to Pine Forge Road as part of planned improvements for the *Leaf* Creek Farm land development plan. Mrs. Boyer stated they didn't hear anything further until recently when they received a letter from Boyer Engineering stating they wouldn't be changing the driveway; they would be milling only. Mr. Boyer stated he contacted Brian Boyer, who claimed he submitted the Boyers request to move the driveway and they weren't in favor of moving it. Mr. Jones stated the developer must make submission to the Planning Commission, and these details could be addressed in the planning phase. Mr. Jones recommended the Boyers call the Township office to find out when the developer is on the Planning Commission agenda. Mrs. Boyer stated they were told this is an "over 55-year old" community that wouldn't affect peak traffic, but she'd disagree; most 55-year olds still go to work and would add to traffic. Mr. Boland stated the developer presented a concept idea and may not be ready for plan submission until April. Kellie Tully, Pleasant View Drive, questioned how *TowerDIRECT* was chosen for EMS in Amity. Mr. Jones stated staff reached out to EMS providers and only one provider was staffed and interested in providing service in the Township. Mrs. Tully asked where the ambulance would be located. Mr. Weller stated Western Berks EMS was housed at Amity Fire Company and chose to not continue providing services based on financials. Mr. Bingaman stated ideally, TowerDIRECT would like to be located along the SR422 corridor. Mr. Jones stated the Township can't dictate where TowerDIRECT is located. Mrs. Tully stated she is a kidney transplant patient and has concerns about response time. Mr. Bingaman stated that ultimately, the closest ambulance would respond to emergencies. Mr. Boland explained the Township tried to provide Western Berks EMS a site they could build, but their Board of Directors weren't interested and turned it down. Ms. Tully asked if that would be offered to TowerDIRECT. Mr. Bingaman stated the Township no longer owns the property. Mr. Keifrider stated Senator Pennycuick met with staff and acknowledged the EMS crisis exists everywhere. Mr. Bingaman stated Rep. Gillen also spoke about the crisis with EMS. Mr. Keifrider stated more information will be communicated as it becomes available, through the Township website, Facebook page and newsletter.

EXECUTIVE SESSION AND ADJOURNMENT

At 8:04PM, with no further business, Mr. Keifrider moved, seconded by Mr. Hackett to adjourn to *Executive Session* to discuss potential litigations, real estate and personnel matters with no need for return.

Meeting adjourned at 8:04PM.
