## A New Look for Tollgate Road

The Board of Supervisors is moving forward with the realignment of Tollgate Road. The project started with the acquisition of the Tollgate House property in 2006. The historic building was dismantled by the Amity Heritage Society in 2007 and moved to the Cultural Heritage Center in Kutztown. Tollgate Road, as shown to the right, will be moved North to intersect directly across from Nicholson Avenue. The new intersection will be widened and will have two turning lanes on Old Swede Road. The old Tollgate Road will be abandoned. The design phase is nearly complete now and the Township is proceeding with acquiring rights-of-way and construction easements. When all property agreements and applicable permits have been obtained, the solicitation of bids can begin. Hopefully construction can start late next year and be complete within six months.

## Make your home a solution to stormwater pollution! 10 things you can do to prevent stormwater runoff pollution

As stormwater flows over driveways, lawns, and sidewalks, it picks up debris, chemicals, dirt, and other pollutants. Stormwater can flow into a storm sewer system or directly to a lake, stream , river, wetland, or coastal water. Anything that enters a storm sewer system is discharged untreated into the waterbodies we use for swimming, fishing and providing drinking water. Polluted runoff is the nation's greatest threat to clean water. You can adopt these healthy habits and help protect our lakes and streams, riv-
ers, wetlands and coastal waters. Remember to share these habits with your neighbors.

- Use fertilizers sparingly and sweep up driveways, sidewalks and gutters.
© Never dump anything down storm drains or in streams.
© Vegetate bare spots in your yard.
© Compost your yard waste.
© Use least toxic pesticides, follow labels, and learn how to prevent pest problems.
© Direct downspouts away from paved surfaces; consider a rain garden to capture runoff.
© Take your car to the car wash instead of washing it in your driveway.
© Check your car for leaks and recycle your motor oil.
© Pick up after your pet.
© Have your septic tank pumped and system inspected regularly

## Coming Soon to Amity

You've probably noticed the construction at the Villa At Morlatton. Developers are busy with their latest phase of the project-an 81 unit assisted living and memory care facility. This latest expansion will be a three story, 80,000 square foot facility connected to the existing building by an elevated walkway. The assisted living facility will offer studio, one and two bedroom units; 24 hour nursing care; meals; various therapeutic and social activities; housekeeping and linen

## Monocacy Creelk Interceptor

The Township continues the process of acquiring rights-of-way for the new public sewer line that will service BelAir Estates and the Valley Road properties. The new interceptor will provide relief for the failing on-lot systems as identified in the Township's Act 537 plan. We anticipate starting construction in the Spring of 2009. Cost estimate of this project is $\$ 2,500,000$ to be paid with Sewer EDU funds.
services. The estimated cost of this expansion project is $\$ 15$ million. The new building will create 70 full time and part time jobs. Developers estimate the facility to be open by Summer 2009.

Across the highway on Rt. 662 Greth Homes is building a 79 unit, $\$ 5$ million assisted living facility called Hearthstone at Amity. Amenities include three meals daily, licensed nursing care available 24 hours a day, transportation to appoint-
ments, recreational activities, onsite banking services and more. Units are available in private and semi-private apartments. The facility will have a hair salon, movie area, exercise area and a card/game room. Construction began in August and is expected to by complete by March 2009. The first residents may move in as soon as April. The project will create 50 new jobs for Amity Township.

Mailbox Reminder
With winter on the way, you may wish to evaluate the condition of your mailboxes. It is the policy of the Township regarding damaged mailboxes: "Only mailboxes directly struck or hit by the plow or vehicle will be considered for reimbursement by the Board of Supervisors'. Mailboxes must be able to withstand thrown ice and snow
© When you meet or overtake a stopped school bus with red signal lights flashing and stop arm extended, you MUST STOP.
© When you approach an intersection where a school bus is stopped with red signal lights flashing and stop arm extended, you MUST STOP.
© You MUST STOP at least ten (10) feet away from the school bus.
© You MUST WAIT until the red lights have stopped flashing and the stop arm has been withdrawn before moving.

© DO NOT MOVE until all the children have reached a place of safety.

## Old Man Winter is on his way!

Amity Township's Zoning Ordinance Chapter 26, Part 4, Section 406 says that it shall be the duty of the owners of the land abutting upon any curbs and/or sidewalks to keep them in such repair and condition that they may not be or become dangerous to the welfare and safety of the traveling public. Under the International Property Maintenance Code, Section 302.3.1, where sidewalks exist, those responsible for sidewalks shall have at least a two foot wide path cleared of snow and/or ice within 24 hours after the cessation of the snowfall. Snow covered sidewalks can potentially cause children and adults to enter the street to walk or to ride school buses. Please remember

to clear your sidewalks.
Section 104 of the Amity Township Code of Conduct makes it unlawful to plow, shovel or otherwise cause snow to be deposited onto a public street. This practice can cause accidents and necessitate additional costs for snow removal. Penalties include fines and costs not to exceed $\$ 1000$.

Section 103 of the Motor Vehicle and Traffic Code of Amity requires for any winter storm where there is accumu-
lation of one inch or more of ice and/ or snow, all motor vehicles must be removed from public streets. This is to allow the Township plows to do their job quickly and efficiently. Penalties for non compliance include fines up to $\$ 100$, towing and costs.
PennDOT also reminds you that it is illegal to push snow from a parking lot or driveway onto a state highway.
