Maplewood gets a face lift!

Paving will soon start on Maplewood Drive. Beginning at the new CVS and extending to the 400 block of Maplewood. A new 5" thick base will be installed with a 1.1/2" wearing course on top. All the curbs and some sidewalks and driveway aprons will be replaced. Local traffic will be maintained during construc-

Permits are being obtained for the realignment of Tollgate Road at 662. Rights of way need to negotiated so the roadway can be redesigned to intersect 662 across from Nicholson Avenue.

A joint permit with the Army Corps of Engineers is works for the Geiger Road Bridge Project. The Township will investigate funding sources to build the culvert to reopen the bridge.

Storm drainage work in Amity Gardens will continue this summer.

Final right of way acquisitions are nearly complete for the Monocacy Creek Sewer Interceptor. Construction is anticipated to start in Summer or Fall of 2008.

Sewage Management Ordinance

Adopted May 30, 2006. Amity Township's sewage management ordinance was required by Commonwealth of Pennsylvania. All septic tanks need to be pumped and inspected at least once every three years. The ordinance was implemented in 2007. The Township was

divided into three areas and letters were sent to residents with on-lot systems informing them of the need to have their system pumped and inspected. The fee for the inspection is \$65, which covers the cost of the sewage enforcement officer to come to your home. By having

your tank pumped and inspected you will be extending the life of your system and helping to protect the waters of the Commonwealth. For more information on the sewage management ordinance and on-lot systems visit website our www.co.berks.pa.us/amity.

Nonpoint source (NPS) pollution is the Nation's largest source of water quality problems and occurs when rainfall, snowmelt, or irrigation runs over land or through the ground, picking up pollutants, and depositing them in rivers, lakes and coastal waters or introducing them into ground water. The most common NPS pollutants are **sediment** and **nutrients**. Other common NPS pollutants include pesticide, pathogens, salts, oil, grease, toxic chemicals and excess **fertilizer**.

The watershed approach is one way to determine the effectiveness of management techniques it looks at a waterbody and all the potential sources of pollution that drain into it. Water conservation uses technologies that limit water use in the bathroom, kitchen, laundry, lawn, driveway and garden, thereby reducing the demand on existing water supplies and limiting the amount of water runoff. Implementation of best management practices (BMP) include pollution control measures that can be used to prevent or reduce the impacts from activities that may cause water pollution. Examples of BMP's include erosion control techniques like silt fencing, establishment of riparian (vegetated) zones next to water bodies to filter out pollutants, and xeriscape landscaping which incorporates native species, proper irrigation, mulches, and appropriate maintenance schedules. Many local groups organize volunteer monitoring efforts which provide information that can help government agencies understand the magnitude of NPS pollution on the environment.

Recycling

Amity's recycling day is Friday. Please put your recycling bins at the curbside Thursday evening. If Christmas, New Years or the Fourth of July falls on a Friday, pick up will be on Saturday. Additional bins are available at the Township office for \$10 each. Please rinse and compact large plastic containers so they are less likely to blow around.

We now have drop off locations for yard waste: at 2004 Weavertown Road and 120 Old Philadelphia Pike. Leaves must be in biodegradable bags (no grass clippings) and yard waste must be tied and bundled (bundles must be no larger than 36"x36" and under 20 pounds). Bags are available at most local home centers.

Tips for Reducing Solid Waste REDUCE

- Reduce the amount of unnecessary packaging
- Adopt practices that reduce waste toxicity

REUSE

- Consider reusable products
- Maintain and repair durable products.
- · Reuse bags, containers, and other items
- Borrow, rent or share items used infrequently
- Sell or donate goods instead of throwing them out

RECYCLE

- Choose recyclable products and containers and reuse them
- Select products made from recycled materials
- Compost yard trimmings and some food scraps

RESPOND

- Educate others on source reduction and recycling practices.
 Make your preferences known to manufacturers, merchants, and community leaders
- Be creative; find new ways to reduce waste quantity.

Provide supervisors with recommendations on all aspects of economic development in the Township

What's New with the EAC

The Amity EAC has been working with the Berks County EAC to create a radon awareness pamphlet specific to this region. According to the Berks County EAC, the pamphlet will be available for distribution by Earth Day, April 22.

The Amity EAC has begun to discuss recycling in the school district, and is also working on public education and awareness to increase our means of recycling.

An Environmental Resource Inventory (ERI) is being compiled by the EAC to provide the Township with an inventory of our valuable resources with respect to wetlands, waterways, steep slopes, floodplains, property boundaries, aerial photographs, historical sites, and other environmentally sensitive areas. This information will be useful in land planning and development as Amity grows as a viable community into the next century and beyond.

The Amity EAC meets the second Monday of the month at 7pm in the Township Building

Don't get wet when installing your pool!

Some notes from the Code Dept, dedicated to the general health, safety and welfare of the citizens of Amity.

Q: Do I need a permit to install a swimming pool?

A:Yes. Applications are available at www.co.berks.pa.us/amity or here or at our office. The fee is \$50 for the zoning permit + \$104 building permit for above-ground pools and \$154 for in-ground pools. Processing usually takes 7-10 business days.

Q: What about an inflatable pool?

A: If the water is 24" deep or deeper, it is classified as a pool. They require the same permits and inspections. Fences may also be required.

Q: Where can I put my pool?

A: In the side or rear yard only. The pool, filter, equipment, decks and accessories must all be setback at least 10' from the rear property line and setback at least the

required distance from the side property line based on the Zoning District your property is in. Setbacks will be listed on your Zoning Permit.

Q: Do I need to put up a fence?

A: Possibly. All pools must have a barrier that is 48" high surrounding the pool. Some above-ground pools are higher than 48", which create the required

barriers. Ladders to pool must be lockable. If there is any access to pool that is less than 48", most likely a fence must be installed. Additional information on codes for various types of fencing is available on our website.

Q: Where can the fence be placed?

A: Fences 4' high must be placed within the property lines. Fences over 4' high must be setback 2' from the property line and may not be in the front yard. All fences must be kept out of all easements, wetlands, right-of-ways and sightlines of street intersections.

Q: Are there any inspections?

A: Yes. You will need to call & set up 3-5 inspections. They will be listed on the back of the permit. Upon approval of the final inspection, a certificate of occupancy will be signed and mailed to the applicant. The pool may not be used until you receive this document.

Q: What about the electric and associated codes?

A: Various electrical codes from the Int'l Residential Code regarding pools are available on our website. Visit us at www.co.berks.pa.us/amity.
