Did you know?

- Alkaline batteries can be disposed of in the regular trash.
- Latex paint should be dried and hardened before disposing in regular trash. If you want to shorten the dry time, pour kitty litter or saw dust in the can to absorb the paint.

Collection dates are intended to provide *Berks County* residents with a responsible way to dispose of old, unusable and unwanted hazardous products. Putting these items in the trash or down the drain contributes to the pollution of our air and drinking waters.

Amity Township Recycling Collection



Recycling is collected by Eagle Disposal on **Wednesdays**. Weeks where the holiday falls on a Monday, Tuesday or Wednesday recycling will be collected on **Thursday**. Recycling is single-stream; meaning you place all metal, paper, cardboard, glass and plastic into your recycling containers. These materials are sorted at the recycling processing center. You should be receiving a notice from Eagle Disposal for their 2020 collection dates.

Proper Disposal of Medications and Medical Waste

The Amity Township Police Department has a **Medication Drop Box** located in the front lobby of the Township Building located at 2004 Weavertown Road. The purpose of the Medication Drop Box is to dispose of these items in a safe and efficient manner further preventing children from being exposed to medications. Township residents are encouraged to bring their expired, unwanted, or unused prescription medications (or over the counter medications) to dispose of them in the Medication Drop Box. Medications may be dropped off anytime Monday through Friday from 8:00am to 4:30pm, excluding holidays.

What is the proper way to dispose of needles? Needles are considered "sharps". Syringes, lancets and any devices with points or edges that can puncture or cut the skin are also considered sharps. Place them in a strong plastic container, such as those used for laundry soap, bleach or kitty litter. When the bottle is ³/₄ full, put the lid on it and seal the container with duct tape and label DO NOT RECYCLE. Place the container in the trash, NEVER in the recycling container. You can also locate a sharps disposal location at <u>safeneedledisposal.org</u>.

Items that are **NOT ACCEPTED** in the Medication Drop Box are: • NEEDLES

- Bio Hazardous Waste
- Aerosol Cans
- Aerosol Can:

- Liquids

LEAF AND YARD WASTE COLLECTION

The Township now has two leaf vacuums, which will hopefully help move collection along faster! The road crew will begin leaf collection by zones, beginning on November 25th. For your convenience, roads are listed below by the collection zones. Zone 1 may take upwards of two weeks, weather permitting. If your road is not listed in any of these zones, collection will commence following collection of Zone 3. The road crew will go through the Township by zone one more time, weather permitting.

Leaves should be raked into a pile at the curb, making sure leaves are not piled next to mailboxes or trees. Please do not bag leaves! The Township will not pick-up bagged leaves. Keep storm sewer drains clear of leaves. Cars should not be parked over piles of leaves.

YARD WASTE COLLECTION – The Road Crew will collect yard waste from November 18th through November 22nd. Items should be bundled, tied, or placed in brown paper bags, no larger than 2'x2' and weighing no more than 20 pounds. *No plastic bags, please!*

Don't want to wait for yard waste or leaf collection? The Township now provides THREE forty-yard containers behind the municipal building for leaves and yard waste. Please use brown paper bags. *No plastic, please!* Work is being done to move this to the back side of the parking lot.

PLEASE NOTE: All park restrooms will be closed on November 4th for the season with the exception of the Butch Boyer Memorial Pavilion at Amity Community Park.



Christmas Tree Collection

The Township road crew will be conducting a "pick and chip" collection of Christmas trees beginning on January 2nd. They will follow the same collection route as the leaf collection schedule. The trees will be collected and chipped, and wood chips taken to a Township facility and stored for future use at parks and right-of-ways. Wood chips may be available to residents on a first-come, first-serve basis. As this will be a new process, further details will be released on our website and Facebook page. Watch for updates!

Don't let your Christmas tree end up in the dump! We're asking residents to let your trash haulers know they are not to collect Christmas trees. If you put your tree outside at the same time as your regular trash is collected, please place it on the opposite side so they know not to take it.

If you want your Christmas tree gone sooner rather than later, bring it to the Township building. Please DO NOT put trees in the dumpster. There will be a sign nearby that will tell you where trees may be left.

Don't be caught unprepared when the snow starts falling. Following a few simple rules will make Old Man Winter a little more bearable:

Under International Property Maintenance Code, Section 302.3.1, where sidewalks exist those responsible for sidewalks shall have at least a two-foot wide path cleared of snow and ice within 24-hours after cessation of the snowfall. You must comply immediately to avoid penalties. Penalties can include fines not to exceed \$1,000.00 per day until resolved.

Plow or shovel your snow to the side of your driveway, away from the flow of traffic. Clearing snow for a distance before your driveway allows the plow to "unload" before reaching your driveway.


Additionally, by piling snow away from the direction of oncoming snow plows, the bulk of the snow will not be pushed back onto your driveway making less work for you later! If the snow plow deposits snow in your driveway, please know this is not done intentionally.

Do not shovel snow into the street! Shoveling snow into the street at any time can cause safety issues, not to mention it's against the law, per Chapter 7, Section 104.

Please place recycling bins back from the curb as far as possible during snow events to prevent Township crews from knocking them over while plowing.

Keep an eye on the weather! Per Chapter 19, Section 403, whenever there is accumulation of 1" or more of snow and/or ice, you must remove your vehicle from the street. Police will issue violations of \$40.00 per day for vehicles left on the street with 1" or greater accumulation. You may want to have a back-up plan. If you're not home and your vehicle is on the street, having someone able to move it for you during a winter storm is a quick savings of \$40.00!

Lastly, please help firefighters by making sure hydrants are accessible! If you have a fire hydrant near your house, please remove ice and snow, clear a 3-foot by 3-foot perimeter around the hydrant and clear a path from the hydrant to the street.



SCHOOL BUS SAFETY



Keep kids in our community safe and watch for school buses.

Every year in Pennsylvania children are needlessly injured or killed by drivers passing stopped school buses because drivers are not aware of school bus stopping laws or choose to ignore the law.

- 1. When you meet or overtake a stopped school bus with red signal lights flashing and stop arm extended, you **MUST STOP.**
- 2. When you approach an intersection where a school bus is stopped with red signal lights flashing and stop arm extended, you **MUST STOP**.
- 3. You MUST STOP at least ten (10) feet away from the school bus.
- 4. You MUST WAIT until the red lights have stopped flashing and the stop arm has been withdrawn before moving.
- 5. DO NOT MOVE until the children have reached a place of safety.

The Amity Township Police Department takes complaints of this nature very serious and will be diligent in enforcement of violators. If you observe a school bus violation call 9-1-1. Try to take down the license plate number. Get the location of the occurrence, a description of the vehicle and operator. Take a snapshot of the license plate if possible. And most importantly, forward this vital information to our police department and we will act upon it.

WINTER TIME POLLUTION PREVENTION

Water pollution and conservation are important issues during the spring and summer months; however, there are many things that we can do during the winter months that will help reduce water pollution and help conserve water. Below are three topics with several tips on how to make a difference this winter:

- 1. Too Much Salt: When the snow and ice melt after a winter storm, the water flow will take with it anything that it collects on the ground and wash it down storm drains. This means that melting ice will carry the deicer materials that we use to clear our driveways and walkways down storm drains and into local waterways. The chlorides that make up the deicers can harm aquatic wildlife, affect nearby plant growth in your yard, and can remain trapped in your soils. Luckily there are alternatives to conventional rock salt deicers that are easy to purchase and will also help in keeping our pathways safe! Here are some helpful tips that will keep your pavements clear and local streams cleaner!
 - Removing freshly fallen snow before it has a chance to freeze and harden into ice is one of the more effective ways of keeping your pavements clear. Deicers work better when there is only a thin layer of ice or snow.



- If you are using traditional rock salt, the recommended application is a handful for one square yard. Using more salt
 than this will not make the ice melt faster; it will only end up costing you more money and the salt will be washed
 away by the stormwater!
- Pay attention to the type of deicer material you're applying so that you reduce the risk of damaging your sidewalk and driveway.
- Mixing sand in with the deicer will also aid in melting the snow and ice and allow you to cut back on the amount of rock salt that is being used. Sand and regular brand kitty litter will also add traction to the surface as well. But remember, if there is left over sand and kitty litter on your walkway or driveway, use a broom to clean it up. Using a hose to wash the sand and kitty litter away will push the material into nearby storm drains and potentially cause a clog or back-up of the drains, so put that broom to work! **Fertilizer is not an appropriate substitution for any of the above materials.**



- 2. Loosing Water: Bursting pipes in the winter time can cause a strain on water supply levels and also on a homeowner's wallet. By preventing pipe bursts and water loss now, you can help conserve water and money!
 - If you have outside spigots, turn them off during the winter months to prevent them from bursting due to the cold temperatures.
 - You may be able to turn the spigots off by an inside valve, and then drain the remaining water from the pipes.
 - Make sure that your water pipes are insulated properly and check for leaky pipes now before freezing temperatures arrive.
- 3. Household Hazardous Waste: It is important to dispose and use our cleaning products appropriately. The water that goes down your sink drain also carries residues from your home, and many harsh household chemicals are not removed by sewage-treatment or septic systems.

Household Hazardous Waste is any household product which is labeled: CAUTION, DANGER, FLAMMABLE, EXPLOSIVE, TOXIC, WARNING, CORROSIVE, POISON and VOLATILE or any combination of these characteristics



Here are a few things that will help reduce these problems with household chemicals:

- Read your labels and know what is in the product before using it.
- Consider using products that are "environmentally friendly". These products will advertise that they do not contain phosphates, chlorine, ammonia, etc. (all of which contribute to water pollution).
- Store household chemicals in a dry area with the lids secured tightly.
- Use only the recommended amount of the product.
- Never dispose of chemicals in storm drains (they lead directly to nearby rivers).
- When disposing of household chemicals, check to see if there are special instructions and/or collection sites for your convenience. In Berks County, the Berks County Solid Waste Authority hosts Household Hazardous Waste Collections in the Spring and Fall to help homeowners dispose of household chemicals. On-Lot Tanks - to Pump or Not to Pump

Although some septic haulers recommend pumping your system every two (2) years, Amity Township Ordinance regulations, which were mandated to match PA DEP regulations, require all on-lot septic tanks to be pumped and inspected every three (3) years. In the spring of the year in which you are required to pump, a reminder is mailed to each homeowner by the Township explaining the program. Additionally, an expiration date is listed on the Certificate of Compliance you received during your last cycle. It lists the year you are to have it pumped and inspected. Should you choose to have it pumped on a non-required year, please keep the hauler's inspection report card and pump slip and turn it in when you receive the spring reminder letter. Amity Township accepts pumping report cards within one year from the date you turn it in. You will then be required to meet the Ordinance three (3) years from the time you had it pumped. Feel free to call 610-689-6000, ext. 232 for any additional information.

RV Parking on Properties

Parking RVs and other trailers is permitted on your lot any time of the year with a couple specific exceptions. They may not be parked in front of the front yard building setback line. These setback lines are as follows: Woods Edge, High Meadows Estates, Sunset Knoll and some of Greenbriar Estates have a front yard setback line of forty (40') feet. Westridge, Amity Gardens, Lenape Farms, Rosecliff Pointe, Sunrise Hills, Pond View, Cider Mill Run, Pleasant Meadows, Glenwood Estates, Far Hill Farms and some of Greenbriar Estates have a front yard setback line of thirty (30') feet. Front property lines are generally two (2') feet in from your side of the sidewalk. Yellowhouse and Indian Run Subdivisions have a front yard setback line of fifty (50') feet. These front property lines are twenty-five (25') feet from the centerline of the street. Although you might think a driveway is ok, most driveways are within this nonpermitted area. Please park your RVs in a permitted location. Illegally parked vehicles can lead to enforcement action.

Soliciting / Peddling in Amity Township

Soliciting in Amity Township is governed by Township Ordinance, found in Chapter 17, Part 2 of the Township's Codification. Be advised, Soliciting is a Constitutional Right and case law further dictates the allowance of these activities. Should someone knock on your door to sell products or services, please ask to see a copy of their permit. Permits allow solicitation during certain hours only. If they do not produce a permit, please ask them to leave and contact the Police Department at 610-689-6002 or 610-655-4911. If you would prefer that these folks not knock on your door, we recommend placing a "No Solicitation" sign by your door. PARKING ON PUBLIC STREETS: A Message from the Chief of Police

Residents often call with questions about what types of vehicles may be parked on the street and whether Amity Township permits PODs or dumpsters in the street. Chapter 19 of the Amity Township Code of Ordinances, Section 404 states:

404(a) no recreational vehicle, whether motorized or non-motorized, including but not limited to travel trailers, motor homes, truck campers, tent campers, trailers, boats and trailers, snowmobiles and trailers and any other similar vehicles shall be parked on any street within the Township; provided, however, that such vehicles may be parked on the public street temporarily for the purpose of loading and unloading such vehicle, in which case it may be temporarily parked for not more than 24 hours in each week (Sunday through Saturday).

404(b) no truck, tractor, semi-trailer, trailer or other vehicle having a gross vehicle weight rating of more than 14,000 pounds (Weight Class 6 or greater) or having a width in excess of 80 inches shall be parked on any street within the Township, except for the purposes of making pick-ups, deliveries or construction activities, in which case it may be temporarily parked for not more than eight hours between the hours of 6:00 a.m. to 6:00 p.m.

404(c) no construction equipment or materials shall be parked or stored on any street within the Township. No dumpster or storage container shall be placed on any street within the Township. Please Note: This means you may not place a dumpster or POD in the public street.

Laws are passed with safety in mind. If you believe you see a vehicle parked illegally on a public street within the Township, please call 610-689-6002 and press 1 to speak to an on-duty Police Officer. *As always, thank you for your cooperation!*


Turn your clocks back one hour on November 3rd. This is a great time to change batteries in your smoke detectors and review escape plans with your family.

EYEGLASS COLLECTION Help give the gift of sight

There's a tremendous need for recycled glasses throughout the world. Each year, individuals donate approximately seven million pairs of glasses to their Lions Clubs International Eyeglass Recycling Centers. The New Jersey Lions Eyeglass Recycling Center (NJLERC) at the Katzenbach School in West Trenton is this region's closest center.

The purpose of the NJLERC as an organization is to collect, clean, neutralize and designate the prescription of used eyeglasses and to store and package them for needy groups and individuals throughout the world.

As of August 2012, the Lions host 18 centers around the world. There are several countries with approved Lions Eyeglass Recycling Centers; located in Austria, Canada, France, Italy, Republic of South Africa, Spain and the United States. According to the Lions Clubs International, 70,330,006 pair of used eyeglasses were collected, and 33,136,463 pair have been distributed since 1995.

Amity Township Lions and Lioness Clubs have participated in eyeglass collection for many years. You may see boxes at various locations throughout your community. A few times each year, a regional or district representative from the Lions Club stops at each

collection location to gather all the collected eyeglasses and takes them to the NJLERC where the glasses are sorted for actual recycling or identified, sterilized and divided by script in the reading room. Glasses are then bagged and labeled to be sent with those traveling on mission trips to underprivileged foreign countries.

Kim McGrath is the Amity Township Chairperson and volunteers with the Lions and Lioness Club and has even been on several medical mission trips. On these trips a \$7,000.00 camera machine is used to provide screenings to identify the needed prescriptions. Volunteers then help fit glasses to the local poor. Kim traveled to Columbia in September this year to fit over 1,000 poor of Columbia and Venezuela refugees with eyeglasses.

Restoring Your Trails



In the last 18 months our area received an incredible amount of precipitation. The water table (groundwater level under the surface) is the second highest ever recorded in Berks County. 2018 was the record wettest year in this area with a total of over 68 inches of precipitation. 2019 has accumulated high rainfall totals as well. Anyone who has hiked



at Monocacy Hill recently has no doubt noticed some muddy and wet spots and probably had to clean off your hiking boots and your dog's paws!! Many of you may not know that most of Monocacy Hill is steep slopes, with over 25% grade slopes in some areas of the park. With all of the recent rain, some trails have eroded and low lying areas have remained wet. We assess the trails in the park on a regular basis. Last fall we determined that something needed to be done about a small section of Lower Trail to alleviate the muddy conditions in that area. In March we completed that project, spreading two layers of stone on 300 feet of trail. This project was done with the help of Amity Township who picked up and delivered the stone for us. Thanks!

Thank you to our MHCA supporters and volunteers who make these improvements possible!



A huge thank you to 84 Lumber for the awesome discount on lumber for the boardwalk! Creek Trail has always been one of wettest trails in the park. Several years ago we constructed boardwalks on Upper Creek Trail and two other sections of the trail had to be rerouted because of erosion. From time to time our volunteers cut wooden plates so hikers have a surface to walk on. This summer after continued wet conditions, we discussed options for a more permanent solution. We are happy to report that the Spotted Lanternfly population has decreased significantly on Monocacy



Hill and most of southeastern Berks County. This past spring we completed our grant project with Schuylkill Highlands and PA Dept. of Agriculture to remove Ailanthus Trees from the park. We hope that we have seen the last invasion of these insects, but keep your eyes open!
