LTL Consultants review letter dated 10/06/15. Mr. Hunsburger stated most items they will comply with and Mr. Boyer and Mr. Weber agree will meet to resolve other issues. Items he did wish to review were:

- 1. This plan has not been submitted to Penn Dot. Mr. Boyer is preparing the submission.
 - 2. Sidewalks are designed on both sides of the street.
 - 3. There will be an HOA to maintain lawns, shoveling, sidewalks, etc.
- 4. The Recreation Fee will be further discussed. Mr. Hunsburger requested Mr. Boyer look at possible open space and pay a prorated in lieu of fee. Mr. Weber advised Mr. Boyer to prepare a definite proposal for review.
- $5.\ \mathrm{Mr.}$ Hunsburger & Mr. Weber agreed to full compaction to the Utility Trench Backfill with TelVil Corporation testing and inspections by LTL provided a note is added to the plan.
