The Planning Commission discussed the revised proposed ordinance:

1. The brightness of the signs is not address in this ordinance. Mr. Weber stated it is in the lighting ordinance measuring by foot candles. Foot candles need to be measured at the site to verify compliance.

2. Mr. Musheno advised there is pending legislation that may set more controls on electronic signage. Mr. Musheno agreed to continue monitoring the legislation and review our ordinance to verify our compliance. In the event we need to make changes he will prepare for our review. There is no time table when the legislation may be considered.

3. Mr. Weller asked if we do need to make any changes can we please also look at the scrolling, fading, etc to best utilize the features for our commercial community. Mr. Jones moved, seconded by Mr. Weller to recommend the Board of Supervisor's adopt the Sign Ordinance Version 11W4141-13 as presented. Motion Carried Unanimously.
