MS4 - Municipal Storm Sewer System

Ashley J. Showers , Planner II, Berks County Planning Commission

Her attendance this evening was to fulfill Amity Township Requirements for public education for MS4 Permitting. She presented information about MS4 and what it means to Amity Township. She discussed Amity Township and many other communities across the state are required to comply with the US EPA and PA DEP protocols for any new permits issued since 2013 based on the 2000 Census. The protocols are designed to control stormwater from curbing, water basins, swales and municipal storm sewer systems. MS4 does not control Sanitary Sewer Systems. The public is encouraged to become involved in Clean ups in the community. Other suggestions were sweep up any extra salt left after storms and use another time, use public cars washes and if you chose to wash your own car at home it is recommended to wash on your lawn and not the street. Citizens are encouraged to not mow up to a stream on their property but allow a 5 foot buffer and the use of rain barrels is encouraged. Rain Gardens are aesthetically pleasing and more information is available at the Berks County Conservation District Site. Arrangements can be made for a presentation to the Township about rain gardens. No questions from the audience at this time.
