Mr. Buckwalter moved, seconded by Mr. Jones to approve the minutes of the Regular meeting of November 14, 2018. *Motion carried unanimously*.

DARNOC LAND DEVELOPMENT-PRELIMINARY-656 BEN FRANKLIN HWY-COMMERCIAL WAREHOUSE-Boyer Eng Mr. Brian Boyer discussed LTL's review letter dated 12/7/18. Mr. Boyer will submit the Architectural drawings requested. Mr. Boyer is waiting Amity Township Fire Marshall and PennDOT's review letters. He has received BCCD NPDES Permit approval and this addresses the Stormwater issues raised in LTL's letter. Parking was discussed and there are parking spaces listed on the plan to expand in the future. The stormwater is designed to handle all parking. The Traffic Impact study was discussed. The Commission agreed they will recommend the Board of Supervisors not require a traffic Impact Study, provided the owner pay for 1 trip per day. Mr. Boland requested a note be placed on the plan the developer is abandoning the current east side of the driveway and adding plantings. Mr. Boyer will comply.

SPEEDWAY LLC-GAVIN LAW, LLC/RUSSELL T MCFALL, PE - DIESEL PUMPS - PRELIMINARY PLAN

Mr. Gavin reviewed the plan previously received a Zoning Variance. The Zoning Hearing Board previously waived the requirement of a landscape buffer along 422 East and West. He further explained this was a request from the police to keep things open and airy to enable them an open view when they drive by on either side of 422. They do not have to drive through the parking lot to keep things under surveillance. Mr. Gavin also stated they are waiting for PennDOT and NPDES approvals. Mr. Jones moved and seconded by Mr. Buckwalter to recommend the Board of Supervisors grant Preliminary Plan approval based on LTL's review letter items all be completed as agreed upon by LTL and the Developer. Motion carried unanimously.
