TOWNSHIP MANAGER REPORT:

The Fishing Rodeo request for funds was taken to the Supervisors but as reported at the last Park and Recreation meeting, there is no money in the budget to support this event.

Chazz spoke with Tom Legath regarding the Licensing Committee meeting. Due to budget process, Tom has asked to delay the meeting.

DBYA approved the field agreement but DBCA has not completed the review at this time. Tony has been hospitalized.

Mons Jones House Parking Lot: Chazz asked for a cost sheet for the project from one of our work crew members. The total cost is projected at \$44,465.91. This cost does not include the stone donation. Chazz is looking to complete Phase 1 at a cost of approximately \$12,000, assuming that the stone is donated. This money is not in the budget so the plan will not be going anywhere. Butch suggested sharing this with Scott Stepp.

Monacacy Hill Project: Letters have been sent to residents in Westridge regarding chemical spraying and the MSDS sheets. This is part of the mini grant that Risa secured.

Water: Chazz received a request to turn the water on for the weekend of April2. Normally this is not done at this time. Chazz is making plans to do so if the weather is warm enough. The restrooms at Monacacy Hill will be pumped.

UNFINISHED BUSINESS:

Tennis Program: The Board of Supervisors approved the Tennis Program. The Recreation Board approved the registration flyer submitted by Chazz.

Proposed Lighting Ordinance: There has been no action taken by the Supervisors. Readings have been taken at the school and are in compliance. The Supervisors have authorized readings taken around the township building and playground.

Chazz asked for a list of addresses and he will send out a friendly reminder. The woodchips have been placed down in the picnic area. They can use more if anyone knows of any wood chips available.
