CALL TO ORDER: Scott Weller called the meeting to order at 7pm with the Pledge of Allegiance to the Flag.

OLD BUSINESS:

1. LAKE DRIVE PAVILION: The paving is complete. The sidewalks are done. The Township did the stonework, dirt moving, & grass planted. They want to get picnic tables back under the pavilion before the cars start driving under. The tables need to power washed & painted. Once that is done the tables will be anchored to the pavement. Township is hoping to have it completed by mid October. Township is about to replace the court lights to LED lights.
2. LITTLE RED MAILBOX OF HOPE: The mailbox is complete and Cyndi Tromley will be traveling to pick it up. It will be placed in the grassy area behind the gazebo.
3. AMITY TOWNSHIP SUMMER PROGRAM: 37 responses on Survey Monkey so far. Troy will be putting it to the school for a news blast.
4. LAKE DRIVE PLAYGROUND: Township has removed a lot of wood fixtures. Play and Park Structures are having a clearance on 2 styles ½ of the package would go to Lefort and the other ½ would go to Lake Drive. One set is \$44740 and the other set is \$28733. Additional 35% for shipping and installation. Also need to get a different set of cameras to help out on the security on the new items.
5. DBAA: Pete Kelly said thanks to the Rec Board & road crew for all the help on making the tourney a success.

  - B. Asked Patrick to clean out the dirt bins
  - C. Need to degrass the infields of Lake Drive. Need to get a big York rake to fix issue.
  - D. Batting cages up at Middle School field. They were taken down by Casey at the Middle School. DBAA is asking to have them put back up. Patrick is going to check with Casey to see if they can put back up at least one.
