- 5. SUMMER PLAYGROUND PROGRAM: 192 peopled answered the survey. Ages 0-5 72children, 5-8 77 children, 8-11 75 children, 11-16 58 children, and 16 or over 30 children. The majority of the children attending would be one from a household. 55 people are very interested in an 8 week program from 9-2. 96 people are interested but want more information. 24 people showed some interest. .As for the cost 28 were not interested in spending any money, 48 \$20-\$30, 61 \$40-\$50, 15 \$60-\$70, 16 \$70-\$80, 24 \$90-\$100. 90 people responded would pay for all 8 weeks for a reduced rate as where 102 would rather pay weekly. As for the question of having extended hours to 4pm 82 said yes to 108 said no.
