CALL TO ORDER/PLEDGE TO THE FLAG: Scott Weller called the meeting to order at 7pm with the Pledge of Allegiance to the Flag.

APPROVAL OF MINUTES: Lisa Miller made a motion, seconded by Scott Weller to approve the minutes. Minutes were approved 4-0.

#### OLD BUSINESS:

- 1. Lake Drive Park Improvements: The color coating on all the courts and skate park are defective. The seal coating that was used didn't adhere to the courts properly. The coating bubbled up, cracked, and has holes in it. A meeting is scheduled with all parties involved to discuss the issues. Troy Bingaman is asking for an extension on the grant due to this issue since the grant runs out 12/31/22.
- 2. Fence Repairs Hill Road: This is still in the works

### **NEW BUSINESS:**

- 1. 2023 Fee Schedule: No changes recommended for 2023
- 2. Park Inspections: Board has agreed to having the inspections but will look at it again April 2023. Nathaniel Halter has taken time to do an inspection of ACP and submitted the following items that he feels need to be addressed. Troy and Randy will be going over the list and will get as many of the issues fixed before the season won't allow it to be done.
  - a. Playground border: replacement of the wood outline
  - b. Playground brick walkway: 112ft X 9ft (power wash bricks)
  - c. Playground border between walkway: spray and 2 yards of mulch
  - d. Macadam: 68 cracks that run across, crack sealer could be used, approximately 6 require patch work.
  - e. Playground weeds (recurring): spray is needed
  - f. Facilities: Bathrooms power washed and painted in both pavilions, recurring upkeep to fix doors, toilets, mirrors (dependent upon usage/abuse)
  - g. Tennis Courts: All six should be resurfaced (They were power washed and painted this past summer) However, there are cracks and portions of the surface that have deteriorated away
  - h. Tennis Courts: Clasps for entry/exit doors missing, hardware replacement.
