

## AMITY TOWNSHIP ANNEXATION PLAN SUBDIVISION

The following procedures are in compliance with the Amity Township Subdivision/Land Development Ordinance.

- 1. Five (5) Paper plus one (1) Electronic PDF format Sets of the Annexation Plan are requested to be submitted to the Township seven (7) calendar days prior to the regularly scheduled meeting of the Planning Commission.
- 2. The plan must be accompanied by an <u>Application For Review Form</u> and submitted to the Township seven (7) calendar days prior to the regularly scheduled meeting, to place the Annexation Plan on the Planning Commission's meeting agenda.
- The application <u>does require fees</u> in accordance with the latest Fee Schedule:
  a.) Application Fee (Same fee as Preliminary & Final)
  b.) Escrow Fee \$1,000.00.
- 4. Three (3) Report copies and Five (5) Supporting Documents copies are required with submission.
- 5. All revised copies must be submitted to the township.
