AMITY TOWNSHIP SKETCH PLAN SUBDIVISION AND LAND DEVELOPMENT SUBMISSION PROCEDURES

The following procedures are in compliance with the Amity Township Subdivision/Land Development Ordinance:

1. Sketch Plan Submission:

Quantity: Five (5) paper copies and one (1) electronic PDF format set of the sketch plan.

Deadline: Must be submitted seven (7) calendar days prior to the regularly scheduled Planning Commission meeting.

2. Application for Review Form:

The submission must include a completed Application for Review Form.

3. Planning Commission Notification:

The Planning Commission Secretary must be notified at least seven (7) calendar days before the meeting to place the Sketch Plan on the meeting agenda.

4. Application Fees:

Application Fee: \$250.00. Escrow Fee: \$1,000.00.

The applicant must sign the application agreeing to reimburse the Township for any additional reasonable fees beyond the escrow fee incurred during the plan review by Township consultants.

Invoices for these additional fees will be sent directly to the applicant.

5. Revised Copies:

Any revised copies of the sketch plan must be submitted to the Township.

6. Final Plan Recording:

The Engineer submitting the plan is responsible for recording the final approved plan.

Once recorded, the applicant must provide an electronic (PDF) version of the recorded plan, including the recording stamp, to Amity Township.
